1. Major Agenda Items & Outcomes

A. CDOT and TPR Policy and Funding Updates

CDOT presented updates to Policy Directive 14 (PD14):

Emphasis on Transportation Safety, Fixing Roads Sustainably, and Expanding Mobility Options.

Funding proposals approved:

\$100,000 reallocated from US 24A to CO 9A for design.

Additional RP funds to CO 67 for maintenance.

No objections raised from online participants.

B. TPR Planning and Project Prioritization

Reviewed Top 20 Priority List: 5 projects completed or under construction.

Approved a data-driven prioritization process using:

PD14 goals (Safety, Infrastructure, Mobility)

Additional local priorities: Congestion, Freight, Tourism, Resilience

Projects recommended for priority list addition include:

US 285 Corridor Improvements

CO 115 Safety Study

US 24 bridge replacement

Regional Transit Service Enhancements

C. Transit Plan and Service Updates

\$460K reallocated from a defunct vehicle facility project to active transportation service (UKoG).

Regional agencies encouraged to participate in CDOT's transit provider survey.

Transit agencies reminded to list infrastructure projects in RTP for FTA funding eligibility.

D. Active Transportation & VRU Safety

Region 2 crash data highlighted increased risk to pedestrians and cyclists.

Survey results:

30% of respondents walk/bike to destinations regularly.

Top barriers: traffic volume, poor crossings, lack of infrastructure.

New Active Transportation Plan goals shared:

Safety, Equity, Mobility Choice, Connected Communities.

E. Broadband Access Discussion

Broadband maps revealed persistent connectivity gaps in rural Teller, Park, and Fremont Counties.

Attendees highlighted discrepancies between FCC data and lived experience.

Starlink and wireless towers cited as key alternatives in remote areas.

CDOT ITS to coordinate with providers on infrastructure projects.
